## Forks of Salmon Elementary School Petition for Transfer of Territory

Mr. Allan Carver reviewed the Forks of Salmon Elementary School lapsation process. He stated that the Petition for Transfer of Territory had been received and that the County Committee has held two public hearings relating to the petition on November 2, 2022. One public hearing was held at Junction Elementary and the second at Forks of Salmon Elementary School. Mr. Bennett asked Mr. Carver for his recommendation.
