**RESOLUTION OF THE BOARD OF TRUSTEES
OF THE GRENADA ELEMENTARY SCHOOL DISTRICT
REGARDING ITS INTENT TO REDUCE BOARD SEATS FROM FIVE TO THREE**

WHEREAS, the Board of Trustees (“Board”) of the Grenada Elementary School District (“District”) currently contains five (5) members;


WHEREAS, Education Code section 5019 provides that the County Committee may decrease a school district’s governing board to three members if the school district had an average daily attendance (“ADA”) of less than 300 in the previous year; and

WHEREAS, the District’s ADA was less than 300 during the 2019-2020 school year.

NOW, THEREFORE, BE IT RESOLVED THAT, the District’s Board does hereby authorize the Superintendent to take any and all steps necessary to initiate the process to reduce the composition of the District’s Board from five (5) members to three (3) members, including submission of this Resolution to the County Committee pursuant to Education Code section 5020, and seeking waiver of the subsequent election requirement from the State Board of Education pursuant to Education Code sections 33050 et seq.
